The Education Committee is committed to the mission of promoting the conservation and appreciation of birds and other wildlife through educational activities for adults and children in the Greater Cleveland community. The backgrounds of our members in science and education is varied and impressive, which contributes to the success of the programs and events offered. It is a privilege to work with such a talented group.

The COVID 19 pandemic challenged us this past year to accomplish our mission within the guidelines presented by the CDC and State of Ohio. All things considered we did a very good job.

#### **Chagrin River Bird Quest**

This is our largest annual event and presents ASGC to the largest number of members and non-members. Inspite of the pandemic the team generated a lot of enthusiasm, and participation far exceeded past years.

Our partners again were Blackbrook Audubon Society (financial support, guided bird walk and sent birding teams to participate) and Geauga Park District (offered an outdoor shelter at no charge to distribute registration materials and sent birding teams to participate). We received significant prize contributions from Wild Birds Unlimited (\$60 in gift certificates) and Centera Coop (\$50 gift card), as well as individual ASGC members making contributions on behalf of vendors unable to contribute this year. 'Thank You' letters were sent to all contributors. Guided bird walks in Lake, Geauga and Portage counties were offered and attended by 32 people, all wearing masks and keeping 'social distance'.

The annual 'New Birders Workshop' was held via Zoom® with 41 participants. The usual handouts were emailed everyone.

A record number of people registered for Bird Quest (167 people in 41 teams) and we allowed birding beyond the Chagrin River Corridor IBA as a way of complying with CDC guidelines to practice 'social distancing'. A record number of species (141) were reported by all teams and the winning team, by species, reported 108. Throughout the day teams were texting or emailing pictures of their teams 'in action' to be used later during the virtual celebration.



A 'virtual celebration' was held via Zoom® at 7:00pm. Because we did not meet in person, when teams picked up their registration materials, we gave each participant a \$10 Subway® gift card to "HAVE LUNCH ON US". During the Zoom® celebration we showed all the pictures submitted throughout the day, then presented the winners in various categories and drew names from a hat for prizes offered by vendors and contributors. Prizes were mailed to the winners. The virtual celebration was well attended and well received.

Chagrin River Bird Quest 2021 will be 'in-person' on September 10-11 and headquartered at The West Woods Nature Center in Russell Township. Check the ASGC website (<a href="www.clevelandaudubon.org">www.clevelandaudubon.org</a>) this summer for specifics.

#### **Science Olympiad Training for Ornithology**

A Zoom® session was held for the Solon High School team with David, Jim, Kelly and Matt answering questions for about 1.5 hours. Students asked many good questions and appreciated the feedback from the group.

Matt Valencic prepared and presented 5 programs to the Medina Schools Science Olympiad Team (4<sup>th</sup> & 5<sup>th</sup> graders) during March and April. Three sessions covered the 95 species they needed to study (Passeriformes, Water Birds of all types, and Raptors, Game Birds and miscellaneous species). Talks were recorded by the coach for teams to review later. Two other sessions (Habitat, Feathers, Feet & Beaks, and Review of 95 Species) were recorded on the ASGC Zoom® account and a link sent to the coach for distribution to the teams. The kids were very excited during the talks, asked lots of questions, and utilized the recordings afterward (based on replay data available on Zoom®).

#### <u>Speakers Bureau – Backyard Naturalist</u>

The mission of ASGC is to promote the conservation of birds and other wildlife through habitat preservation and educational activities. The Speakers Bureau brings the conservation message to hundreds of Greater Clevelanders each year by presenting programs at schools, libraries, nature, garden and civic clubs and other Audubon chapters. The programs are listed on our website homepage under the <u>Backyard Naturalist</u> button.



Because in-person talks were cancelled, the Committee decided to offer one program each month via Zoom® in a *series* called "Third Thursday's". Speakers from ASGC (John Lillich, Sarah Mabey, Jim Tomko and Matt Valencic, Dr. Andy Jones & Ami Horowitz) presented talks on a wide variety of topics including Feeding Birds, The Science of Migration, Owls of Ohio, A Birding Trip to Cuba and Lights Out Cleveland. Talks were actively promoted, and participation varied from 50 to 90 people per talk. The series was very well received and will continue during the 2021-2022 season.

Requests for programs were slow in late 2020 but increased into 2021. A total of 15 programs were presented by Sarah Maybe, Jim Tomko and Matt Valencic during this period. Groups were varied including Audubon chapters, libraries, photography clubs and historical societies. Topics were also varied including specific groups of birds, bird photography, the sensory world of birds and introduction to birding. Regardless of the group, our presenters share the message of bird conservation and appreciation of the environment with joy and enthusiasm.

In all, our Speakers Bureau and Third Thursday's team presented 28 talks during the 2020-2021 period.

2020 was a challenging year for nearly everyone with managing through the CoVID-19 pandemic. The Audubon Society of Greater Cleveland quickly shifted to an online Zoom Education program, maintained Bird Quest with social distancing, and continued email and Newsletter communications.

We maintained our 501 (c)(3) organization status and completed all Federal and State Annual Reporting on time. The public has access to our complete Federal 990 reports via <a href="www.irs.gov">www.irs.gov</a> It is wonderful to be part of an all-volunteer board in which all donations go to the mission of preserving natural lands that serve as sanctuaries for wildlife, providing opportunities for the public to view birds, and conducting educational programs for both school children and adults of all ages.

As you can see in the Profit and Loss Comparison for the year 2020 that is attached, 2020 had a decrease in contributions. Supporters of the Audubon Society of Greater Cleveland have provided Estate Bequests, Memorial Donations, and Matching Funds that have benefitted the Society significantly, providing \$10,948 in 2020. The Annual Appeal together with contributions from National Audubon continues to be our primary source of income providing \$14,045 in 2020. At the bottom of the Profit and Loss statement is the income from investments which increased in value during 2020 by \$58,609.

Education expenses for the year were greatly reduced during 2020 due to not having any in person programs and providing Zoom educational sessions at no cost to the general public. The Bird Quest held in the fall of 2020 with social distancing was our largest educational expenses (\$3000) providing shirts, supplies, and gift card lunches to all participants at no charge.

Sanctuary expenses were similar to previous years except for excavating expenses of \$6200 to clear/repair sanctuary access and for the purchase of a zero-turn lawn mower which cost \$4200 to replace an obsolete and no longer working unit.

Our Newsletter costs for the year were comparable to previous years. Email communications were also comparable to previous year. Web design expenses were slightly higher as the importance of electronic connectivity increased during the pandemic.

Due to good investment returns and prudent spending we ended the year with support of our donors we ended the year with \$464,860 in KeyBank, Vanguard and Merrill Lynch, an increase of \$74,723 compared to December 31, 2019. While we typically budget a draw from our investments of 3.5% of the three-year rolling average, we did not have to use any of the draw last year to fund any of our activities.

Our Sanctuaries have been a popular respite for many people during the COVID 19 pandemic. This allowed for physical and mental health healing while most entertainment was closed down. As the year of COVID wore on, there were fewer hikers than in the beginning. But it does seem as though our sanctuaries have been discovered.

Mark Demyan is organizing work crews to maintain trails and repair bridges, stairs, and blinds. An observation deck is about to be constructed on the beaver pond at the Novak Sanctuary.



Ken Kresina began mowing and maintaining the fields and trails in the Aurora, Novak and Molnar sanctuaries as soon as the weather allowed. Full field mowing is stopped in mid-April to allow nesting birds and other creatures to carry on undisturbed. Strip mowing will continue throughout the summer in order to control Buckthorn invasion. The strips mowed last year will be allowed to grow to provide proper field habitat for native flora and fauna. The plan is to maintain the fields with a 4 to 5 year strip mowing pattern. The strips that were mown in previous years show very good buckthorn control and good emergence of native herbaceous and woody plants.

Mark Magree has been essential in keeping the Education center and the grounds around the Ed center in excellent condition. He has converted rough trails into smooth easily walkable routes. Invasive species are being attacked by mowing, pulling, trimming and judicial spot spraying with an herbicide that has wetland approval.

This year small patches of trillium bloomed again and Ovenbirds were heard calling in the forest.

Once again 2 eaglets are being raised and fledged by their parents in the Novak Sanctuary

We have scheduled a crew from ODNR-DNAP to control the widespread Japanese Barberry at Aurora under the supervision of Adam Wohlever the DNAP supervisor for our area.

First Energy installed power lines along the railroad right of way bordering the north side of the Aurora Sanctuary. The project does not appear to have had any significant impact either physically or aesthetically. For utility poles, they are not obtrusive.

All the sanctuaries are adding to the quality of life for both flora, fauna, and human-kind. We hope to maintain these wild areas for the wildlife both plant and animal as we also restore our own health by visiting these sanctuaries.
